The Autism Waiver Service Provider Enrollment Workshop will review the online application process for enrolling as an “**Autism Waiver Service**” billing provider, including set-up of their “Secure Web” account and available resources. To register for these workshops, visit the [www.ctdssmap.com](http://www.ctdssmap.com) Web site and go to Information, then Publications and scroll down to Provider Workshop Invitation Forms. Select the **Autism Waiver Service Provider Enrollment Workshop** you wish to attend and click on the Registration Link.

**HPE MyRoom Virtual Classroom Training** DXC Technology utilizes internet virtual classrooms that allow class participants to attend a workshop without leaving their office.
