HOW TO REGISTER FOR A WORKSHOP

To register for these workshops, visit the www.ctdssmap.com Web site and go to Information, then Publications and scroll down to Provider Workshop Invitation Forms. Select the Professional Provider Workshop you wish to attend and click on the Registration Link.

- **1-91 NORTHBOUND:** Take Exit 15. At the end of the Exit ramp, turn LEFT onto ROUTE 68 WEST. Proceed approx. 1.8 miles on ROUTE 68 to the *7th traffic light; Turn RIGHT onto BARNES INDUSTRIAL PARK ROAD NORTH; at the traffic light, turn LEFT onto BARNES ROAD; and take FIRST RIGHT into CHA driveway.
- **I-91 SOUTHBOUND:** Take Exit 15. At the end of the Exit ramp, turn RIGHT onto ROUTE 68 WEST. Proceed approx. 1.8 miles on ROUTE 68 to the *6th traffic light; Turn RIGHT onto BARNES INDUSTRIAL PARK ROAD NORTH; at the traffic light, turn LEFT onto BARNES ROAD; and take FIRST RIGHT into CHA driveway.
- **Wilbur Cross (Route 15) NORTHBOUND:** Take Exit 66. At the end of the Exit ramp, turn LEFT onto ROUTE 5 SOUTH. Proceed approx. 1/4 mile to *4th traffic light. Turn LEFT up short hill to next traffic light. Turn LEFT onto ROUTE 68 EAST. At FIRST traffic light; turn LEFT onto NORTH MAIN STREET EXTENSION. Take first RIGHT onto BARNES ROAD. CHA is the SECOND BUILDING ON THE LEFT.
- **Wilbur Cross (Route 15) SOUTHBOUND:** Take Exit 66. At the end of the exit ramp, turn LEFT onto ROUTE 5 SOUTH. Proceed approx. 1/4 mile to *5th traffic light. Turn LEFT up short hill to next traffic light. Turn

LEFT onto ROUTE 68 EAST. At FIRST traffic light; turn LEFT onto NORTH MAIN STREET EXTENSION. Take first RIGHT onto BARNES ROAD. CHA is the SECOND BUILDING ON THE LEFT.

- **I-84 EASTBOUND:** Take Exit 27. Proceed onto Route 691 East. Follow to the WILBUR CROSS PARKWAY SOUTHBOUND. Take Exit 66. At the end of the exit ramp, turn LEFT onto ROUTE 5 SOUTH. Proceed approx. 1/4 mile to *5th traffic light. Turn LEFT up short hill to next traffic light. Turn LEFT onto ROUTE 68 EAST. At FIRST traffic light; turn LEFT onto NORTH MAIN STREET EXTENSION. Take first RIGHT onto BARNES ROAD. CHA is the SECOND BUILDING ON THE LEFT.

- **From Bradley International Airport:** Follow signs out of Bradley towards Route 91 South. Get off exit 35A - Route 291 East, follow it to the end and bear right at the split. Follow the signs for Route 384 East and follow it to the end. At the split, bear right and follow Route 6 East towards Willimantic / Providence; (about 15 to 20 minutes later) you'll see Columbia Ford on your right. At the next light, turn left onto the Route 6 expressway. Take the first exit (Route 32). Turn right off the ramp. At the fourth light (by McDonald's) turn left onto West Avenue, bearing right onto Valley Street at the next intersection. At the first stop sign, turn left onto Mansfield Avenue. The entrance to Windham Hospital is on the left.
- **From Hartford, Connecticut:** Take Route 84 East to exit 59 (Route 384 East) and follow to end. At the split, bear right and follow Route 6 East towards Willimantic / Providence; (about 15 to 20 minutes later) you'll see Columbia Ford on your right. At the next light, turn left onto the Route 6 expressway. Take the first exit (Route 32). Turn right off the ramp. At the fourth light (by McDonald's) turn left onto West Avenue, bearing right onto Valley Street at the next intersection. At the first stop sign, turn left onto Mansfield Avenue. The entrance to Windham Hospital is on the left.
- **From Norwich, Connecticut:** Take Route 32 North towards Willimantic. When you reach Main Street, Willimantic (Dunkin Donuts in front of you at the light) turn left (still following Route 32 N). At the fork in front of Stop & Shop, bear right (still following Route 32 N). Take your first right onto West Avenue, bearing right onto Valley Street at the next intersection. At the first stop sign, turn left onto Mansfield Avenue. The entrance to Windham Hospital is on the left.
