CMAP Addendum B January 2022

The January version of CMAP Addendum B is under development and will be posted to the Hospital Modernization page on the www.ctdssmap.com Web site once finalized.

The Department of Social Services (DSS) will be updating the Connecticut Medical Assistance Program (CMAP) Addendum B to incorporate the 2022 Healthcare Common Procedure Coding System (HCPCS) changes (additions, deletions and description changes) for dates of service January 1, 2022 and forward to remain compliant with the Health Insurance Portability and Accountability Act (HIPAA).

Payment rate changes for procedure codes assigned a status indicator G or K were updated and loaded into the system on December 28, 2021 with a January 1, 2022 effective date for dates of service January 1, 2022 and forward.

Due to the delay in receiving the Centers for Medicare and Medicaid Services (CMS) Addendum B files, DSS is unable to update the claims processing system by January 1, 2022. Any procedure code that is "NEW", changed or deleted will be updated in the near future. A separate communication will go out once the system has been updated.

For dates of service January 1, 2022 and forward the outlier dollar threshold has increased from \$5,075.00 to \$5,300.00.

Re-enrollment Reminder for Hospitals

The hospitals are reminded to take note of their re-enrollment due date with CMAP. Failure to complete and submit their re-enrollment application in enough time to allow for review by DSS by <u>the re-enrollment due date</u> will cause the hospital to be dis-enrolled on the re-enrollment due date.

Dis-enrollment will impact claims processing and the hospitals' ability to verify eligibility until the reenrollment has been completed.

Claims Re-processing

Outpatient Crossover Claim Issue

It has come to the Department of Social Services (DSS') attention that there are claims that electronically crossed-over directly from Medicare to the Connecticut Medical Assistance Program (CMAP) between December 23, 2021 through January 3, 2023 that are denying for Explanation of Benefits (EOB) code 2513 - Other Payer Adjudication Date is Invalid. Medicare has communicated that due to the recent holidays, there was a delay in their batch claims cycle(s), resulting in the Medicare

payment date being later than the date the claims crossed over to CMAP. Claims that set this edit due to the delay in Medicare's payment date(s) were systematically identified and reprocessed and will appear on the hospital's January 11, 2022 Remittance Advice (RA).
