## 2020 HIPAA Compliancy Update:

Effective for dates of service January 1, 2020 and forward, the Department of Social Services (DSS) is incorporating the 2020 Healthcare Common Procedure Coding System (HCPCS) changes by replacing deleted Current Procedural Terminology (CPT) codes with newly added CPT codes to the following fee schedules: Independent Audiology, Speech and Language Pathology, and Independent Physical Therapy and Occupational Therapy.

DSS is making these changes to ensure that these fee schedules remain compliant with the Health Insurance Portability and Accountability Act (HIPAA). The changes apply to services reimbursed under all the HUSKY Health programs.

# IndependentPhysicalTherapyandOccupationTherapyFee:

Effective for dates of service January 1, 2020 and forward, CPT code 97535 will be added to the Independent Physical Therapy and Occupational Therapy fee schedule.
