RE: Increasing the Reimbursement Rates for Select Long-Acting Reversible Contraceptive

Devices

The Department of Social Services (DSS) is updating the reimbursement rates for select Long-Acting Reversible Contraceptive (LARC) devices.

Physicians, Physician Assistants, Advanced Practice Registered Nurses and Certified Nurse-Midwives

Effective for dates of service March 1, 2020 and forward, DSS is increasing the reimbursement rates for the following LARC devices on the physician office and outpatient fee schedule as follows:

Code	Description	Price
J7297	Liletta, 52 mg	\$786.87
J7300	Paragard	\$884.50

Family Planning Clinics

Effective for dates of service March 1, 2020 and forward, DSS is increasing the reimbursement rate for the following LARC device on the family planning clinic fee schedule as follows:

Code	Description	Price
J7297	Liletta, 52 mg	\$100.00

The reimbursement rates for LARCs on the family planning fee schedule is based on 340-B pricing.

Hospitals

Outpatient Hospitals

Reimbursement for LARC devices in the outpatient hospital setting will be determined by the specific procedure code billed for the LARC device inserted/placed. reimbursement rate for LARC devices will be the rate published for the specified procedure code on the physician office and outpatient fee schedule or, for 340B hospitals, the family planning clinic fee schedule. **Hospitals** should utilize the Connecticut Medical Assistance Program (CMAP) Addendum B to determine the payment type for outpatient hospital procedures.
