RE: 2019 Clinic Fee Schedule HIPAA Compliant Updates

Effective for dates of service January 1, 2019 and forward, the Department of Social Services (DSS) is incorporating the 2019 Healthcare Common Procedure Coding System (HCPCS) changes (deletions, additions and replacement codes) to the following fee schedules: rehabilitation clinic, ambulatory surgical center, family planning clinics, dialysis clinic, and medical clinic. DSS is making these changes to ensure that these fee schedules remain compliant with the Health Insurance Portability and Accountability Act (HIPAA). The changes apply to services reimbursed under HUSKY A, B, C and D All providers should refer to each programs. updated applicable fee schedule for more information.

## **Family Planning Clinics**

Effective for dates of service January 1, 2019 and forward, the Department is also updating the fee for procedure code *J7307*, *Etonogestrel implant system*, *including implant and supplies* (*Nexplanon*). All providers should refer to the updated family planning fee schedule for more information.
