

RE: 2019 Fee Schedule HIPAA Compliant Update for Psychological and Neuropsychological Testing

This policy transmittal supersedes provider bulletin (PB) 2018-83 and provides updated billing guidelines regarding psychological testing, neurobehavioral status examinations, and neuropsychological testing and evaluation services. This bulletin applies to the following fee schedules: Physicians, Psychologists, Outpatient Hospital Behavioral Health Clinics, Behavioral Health Clinics, Rehabilitation Clinics and Enhanced Care Clinics. Please Note: Rates have been corrected for the fee schedules listed above.

Effective for dates of service January 1, 2019 and forward, the Department of Social Services (DSS) has incorporated the 2019 Healthcare Common Procedure Coding System (HCPCS) changes (deletions, additions and replacement codes). DSS has made these changes to ensure the fee schedules remain compliant with the Health Insurance Portability and Accountability Act (HIPAA).

Effective for dates of service January 1, 2019 and forward, providers must use the following new Current Procedural Terminology (CPT) codes referenced below, when submitting claims.
