**(1) January 2025 Quarterly HIPAA Compliant Updates - Family Planning Clinic, Medical Clinic & Behavioral Health Clinic Fee Schedules**

Effective for the dates of service January 1, 2025, and forward, the Department of Social Services (DSS) is incorporating the January 2025 Healthcare Common Procedure Coding System (HCPCS) changes (additions, deletions, and description changes) to the family planning clinic, medical clinic, and behavioral health clinic fee schedules.

DSS is making these changes to ensure that the family planning clinic and medical clinic fee schedules remain compliant with the Health Insurance Portability and Accountability Act (HIPAA). The changes apply to the services reimbursed under the HUSKY Health programs (A, B, C, and D).

Please note: DSS will be updating the CMAP Telehealth Table and issuing a separate provider bulletin updating the procedure codes used to bill for audio-only and audio/visual services based on HIPAA updates.

**(2) Updating Physician Administered Drugs on the Family Planning Clinic, Medical Clinic & Behavioral Health Clinic Fee Schedules**

Effective for dates of service January 1, 2025, and forward, the Department of Social

Services (DSS) will update the reimbursement rates for select physician administered drugs on the family planning clinic, medical clinic, and behavioral health clinic fee schedules to be consistent with the January 2025 Medicare Average Sales Price (ASP) Drug Pricing file.

The reimbursement rates for select physician-administered drugs, immune globulins, vaccines, and toxoids will be revised to equal 100% of the January 2025 Medicare ASP Drug Pricing file. Providers should continue to review [\*PB 2018-10 Updates to the Reimbursement Methodology for Physician-Administered Drugs, Immune Globulins, Vaccines and Toxoids\*](#) for more information on billing physician administered drugs. Please refer to the family planning clinic, medical clinic, and behavioral health clinic fee schedules for codes eligible for reimbursement and the January 2025 reimbursement updates.
