RE: April 2025 Quarterly HIPAA Compliant Update – Medical Equipment Devices and Supplies Fee Schedules

Effective for dates of service April 1, 2025, and forward, the Department of Social Services (DSS) is incorporating the April 2025 Healthcare Common Procedure Coding System (HCPCS) changes (additions, deletions and description changes) to the Durable Medical Equipment (DME); Orthotics and Prosthetics (O & P) and Medical Surgical Supplies (MSS) fee schedules.

DSS is making these changes to ensure that the DME, O & P and MSS fee schedules remain compliant with the Health Insurance Portability and Accountability Act (HIPAA). Providers should continue to refer to the fee schedule for prior authorization, quantities, and reimbursement information. The changes apply to services reimbursed under the HUSKY Health (A, B, C, and D) programs.

In addition, providers are reminded to please refer to Table 19 in the fee schedule instructions for the list of quantity limitations for DME, O&P and MSS supplies. To access Table 19 from the fee schedule instructions click here and go to page 5 for the link to Table 19.
