**RE:** Update to Table 26: List of Diagnosis Codes for Medical Nutrition Therapy (MNT) Services

The Department of Social Services (DSS) is adding diagnosis codes to **Table 26**: *List of Diagnosis Codes for MNT Services* for use in rendering medical nutrition therapy (MNT) services. The addition of the diagnosis codes is retroactive for dates of service July 1, 2025, and forward.

Providers should continue to refer to Table 26 for the complete, up to date listing of covered diagnosis codes for MNT services. As a reminder, in order to be reimbursed for MNT services, the applicable MNT procedure codes must be billed in conjunction with one of the primary diagnosis codes listed on Table 26.

With the addition of the new diagnosis codes effective retroactive to July 1, 2025, providers are responsible for resubmitting claims that were previously denied due to the diagnosis code not yet being on Table 26.

Providers must continue to follow policy guidance, documentation requirements and billing instructions outlined in Provider Bulletin PB 2025-18 – New Coverage of Medical Nutrition Therapy (MNT). For further instruction on certified enrollment providers should refer to PB 25-11 REVISED - Certified Dietitian-Nutritionist Enrollment Criteria.
