RE: (1) Update to Procedure Codes S5000 and J7304 on the Family Planning Clinic Fee Schedule and (2) Updates to the Reimbursement for Physician-Administered Vaccines in Family Planning Clinics

(1) Update to Procedure Codes S5000 and J7304 on the Family Planning Clinic Fee Schedule

Effective for dates of service January 1, 2022 and forward, the Department of Social Services (DSS) is adding the coverage of specified drugs to the Clinic – Family Planning fee schedule.

Procedure Code	Description	Drug	Rate
S5000	prescription drug, generic	Fluconzaole	\$10.93
		Terconazole	\$21.39
J7304	Contraceptive supply, hormone containing patch	Xulane	\$81.75

The reimbursement for the drugs listed above is 100% of the current 340-B pricing with an added dispensing fee of \$10.75. Each drug must be billed under the applicable procedure code with the corresponding National Drug Code (NDC).

(2) Updates to the Reimbursement for **Physician-Administered Vaccines**

The Department of Social Services (DSS) is updating the rates for physician administered drugs, immune globulins, vaccines, and toxoids effective for dates of service January 1, 2022 and forward.

The rates for physician-administered drugs, immune globulins, vaccines, and toxoids will be revised to equal 100% of the January 2022

Medicare Average Sales Price (ASP) Drug Pricing file. Providers must continue to include the standard 11-digit National Drug Code (NDC) on all claims for physician-administered drugs, immune globulins, vaccines, and toxoids to avoid it being denied or the incorrect reimbursement.

Providers should continue to review PB 2018-10 Updates to the Reimbursement Methodology for Physician-Administered Drugs, Immune Globulins, Vaccines and Toxoids for more information on billing physician-administered drugs.
