RE: The Addition of COVID-19 Proprietary Laboratory Analyses Codes to the Independent Laboratory Fee Schedule

Effective for dates of service listed below until the Department of Social Services (DSS) declares COVID-19 to no longer be a public health emergency, the following COVID-19 Proprietary Laboratory Analyses (PLA) codes are being added to the Independent Laboratory fee schedule.

Retroactive to the dates listed below, the following PLA codes will be reimbursed 100% of the Medicare rate:

Outpatient Hospitals

The procedure codes listed above that have been updated on the Connecticut Medical Assistance Program's (CMAP's) laboratory fee schedule have also been updated on CMAP's Addendum B. Outpatient Hospitals should continue to follow CMAP Addendum B for coverage and payment of all outpatient hospital services.

From this Web page, go to "Provider", then to "Provider Fee Schedule Download", scroll to the bottom of the page and click on "I Accept", then select the applicable fee schedule.
