RE: Updated Guidelines for Smoking and Tobacco Use Cessation Agents, Counseling and Treatment Products for HUSKY B Members

Effective January 1, 2023, and forward, the Department of Social Services (DSS) is expanding coverage for smoking and tobacco use cessation agents, counseling and treatment products to **all** members enrolled under the HUSKY B program.

This provider bulletin supersedes guidance provided in <u>PB 2017-28</u> "Updated Guidelines for Smoking Cessation Agents, Counseling and Treatment Products", pertaining to the coverage language related to "HUSKY B" members only. All other aspects of <u>PB 2017-28</u> remain in effect and should be used for guidance when billing for smoking and tobacco use cessation counseling and treatment products.

Smoking Cessation Treatment Products

Effective January 1, 2023, and forward, smoking and tobacco use cessation agents and treatment products will be covered for all HUSKY B members. Though the Preferred Drug List is applicable for HUSKY A, HUSKY C, HUSKY D, Tuberculosis (TB) and Family Planning (FAMPL) members, please also refer to the Connecticut Medicaid Preferred Drug List (PDL) for covered smoking cessation products for Husky B members. The PDL can be found on the www.ctdssmap.com Web site. From the Home page, go to Pharmacy Information, Preferred Drug List Information, then to Current Medicaid Preferred Drug List.

Individual Smoking and Tobacco Use Cessation Counseling

When billing for individual smoking and tobacco use cessation counseling codes (99406, 99407), claims will continue to require a nicotine dependency *primary* diagnosis code (i.e., F17.20- F17.299, Nicotine dependence). Effective January 1, 2023 and forward, the secondary diagnosis code related to tobacco use disorder, complicating pregnancy is **no** longer a requirement for payment for smoking cessation counseling for HUSKY B members.

Smoking and tobacco use cessation counseling rendered in the outpatient hospital and federally qualified health center setting and during behavioral health visits must continue to follow the guidance outlined in PB 2017-28 except for the discontinued requirement of the secondary diagnosis code for tobacco use disorder complicating pregnancy.

Dental Practitioners and Smoking and Tobacco Use Cessation Counseling

Group Smoking Cessation Counseling

Effective for dates of service January 1, 2023, and forward, group smoking and tobacco use cessation is covered for all HUSKY B members. For more information regarding Group Smoking and Tobacco Use Cessation Counseling, please refer to <u>PB 2015-37</u> "Tobacco Cessation Group Counseling Services".
