RE: Addition of Cochlear Implant Analysis, Programming and Reprogramming and Standardized Cognitive Performance Testing Services to the Rehabilitation Clinic Fee Schedule

Effective for dates of service January 1, 2023 and forward, the Department of Social Services (DSS) is adding several procedure codes for standardized cognitive performance testing and cochlear implant analysis, programming and reprogramming services to the Rehabilitation Clinic fee schedule.

Please see below for a list of codes that will be payable when billed by Rehabilitation Clinics operating within their applicable scope of practice:

Code Addition	Description	Rate
96125	Standardized cognitive performance testing (eg. Ross Information Processing Assessment, other formal cognitive test); per hour of face-to- face healthcare professionals time, both face to face time interpreting these test results and preparing the report	\$101.66
92626	Evaluation of auditory function for surgically implanted device(s) candidacy or postoperative status of a surgically implanted device(s); first hour	\$86.44

92627	Evaluation of auditory rehabilitation status; each additional 15 minutes	\$20.36
92601	Diagnostic analysis of cochlear implant, patient under 7 years of age; with programming	\$160.87
92602	Diagnostic analysis of cochlear implant, patient under 7 years of age; subsequent reprogramming	\$102.24
92603	Diagnostic analysis of cochlear implant, age 7 years of age or older; with programming	\$150.60
92604	Diagnostic analysis of cochlear implant, age 7 years or older; subsequent reprogramming	\$91.28

The changes apply to services reimbursed under the HUSKY Health (A, B, C, and D) programs.
