

TO: Chronic Disease Hospitals and Acute Rehab Facilities

RE: Addition of Chronic Disease Hospitals and Acute Rehabilitation Facilities Prior Authorization Requests to Medical Authorization Portal

Effective August 1, 2024, chronic disease hospital (CDH) and acute rehabilitation facility prior authorization (PA) requests for inpatient admissions may be submitted via the medical authorization portal.

Accessing the Portal

Providers can access the medical authorization portal on the HUSKY website at: <u>https://portal.ct.gov/HUSKY</u> \rightarrow For Providers \rightarrow Prior Authorization \rightarrow Medical Prior Authorizations.

Portal Registration

New users will follow a two-step authentication process to activate a new user account. Users must complete a Medical Authorization Portal Access Request Form and return to Community Health Network of Connecticut, Inc. (CHNCT) via email or fax. The form and instructions may be accessed at:

Providers who would normally request authorization for inpatient admission to chronic disease hospitals or acute rehab facilities are strongly encouraged to attend the training. The training will cover:

- Creation and submission of PA requests
- Information needed for inpatient admissions authorization
- Location of:
 - Reference numbers
 - Authorization status
 - Determination letters
- Upload of clinical documentation
