**TO: Behavioral Health Clinics, Dialysis Clinics, Family Planning Clinics, Medical Clinics and Free-Standing Substance Use Disorder (SUD) Treatment Facilities**

**RE: Updating Physician Administered Drugs on Select Fee Schedules**

Effective for dates of service January 1, 2026, and forward, the Department of Social Services (DSS) will update the reimbursement rates for select physician administered drugs on the Behavioral Health, Dialysis, Family Planning and Medical clinic fee schedules as well as the Free-Standing Substance Use Disorder (SUD) Treatment Facility fee schedule to be consistent with the January 2026 Medicare Average Sales Price (ASP) Drug Pricing file.

The reimbursement rates for select physician-administered drugs, immune globulins, vaccines, and toxoids will be revised to equal 100% of the January 2026 Medicare ASP Drug Pricing file. Providers should continue to review [PB 2018-10 Updates to the Reimbursement Methodology for Physician-Administered Drugs, Immune Globulins, Vaccines and Toxoids](#) for more information on billing physician administered drugs. Please refer to the Behavioral Health, Dialysis, Family Planning and Medical clinic fee schedules as well as the Free-Standing SUD Treatment Facility fee schedule for codes eligible for reimbursement and the January 2026 reimbursement updates.
